INDEMNITY AGREEMENT

THE STATE OF TEXAS § COUNTY OF FORT BEND

THIS AGREEMENT made as of the _____ day of _____, 20 _____, between _____(father) and _____(mother), parents/legal guardians of the person and estate of _____(son) a minor child, hereinafter referred to as **"GUARDIANS"** and **THE FORT BEND BOYS CHOIR OF TEXAS, INC.**, a charitable Texas corporation, incorporated and existing under the laws of the State of Texas, hereinafter referred to as, **"THE FORT BEND BOYS CHOIR"**.

WITNESSETH:

WHEREAS, THE FORT BEND BOYS CHOIR in taking certain choir members of such group, has elected to make such trip and/or trips in the season of 20____ - 20____, as its Artistic Director may hereafter determine, for the purpose of furthering such minor's education; and

WHEREAS, _____, as a member of such choir group, has elected by his own free will to make such trips, the undersigned as **GUARDIANS**, of such minor child, in consideration of the premises and of such minor's being afforded the opportunity to make such trips, hereby agree with **THE FORT BEND BOYS CHOIR** , as follows:

I.

GUARDIANS, hereby agree that such minor child take such trips and hereby authorize **THE FORT BEND BOYS CHOIR** and its Artistic Director and his appointed designees to take such minor child on such trips and agree that such minor child will be under the control and authority of such officers and that they may exercise supervision over him. The Artistic Director and his appointed designees may exercise control and make all decisions thereunto pertaining, including authorization of medical/dental treatment or surgery from a licensed physician in an office or hospital, when deemed necessary should **GUARDIANS** be immediately unavailable.

GUARDIANS further agree that they will, at all times, hereafter indemnify and save harmless the said Corporation and the said officers, both individually and in their capacity of such officers, from and against all claims, suits, damages, costs, losses, and expenses in any manner resulting from or arising out of minor's participation in such trips. It is understood that any medical, hospital, and surgical expenses, incurred as a result of treatment recommended, shall be borne by such **GUARDIANS** and, to the extent that such expenses may be first paid by **THE FORT BEND BOYS CHOIR**, **GUARDIANS** agree to reimburse it for such expenses. **GUARDIANS** realize that such a trip and/or trips have certain risks involved and understand that every attempt will be made at all times to ensure that safety of said minor child.

II.

In consideration of the amount of time spent involving choir activities, including, but not limited to rehearsals, concerts, workshops, appearances, and choir camp, **GUARDIANS** also agree said minor child shall be under the control and authority of the choir's Directors when participating in choir activities and training, and that said Director may authorize emergency medical treatment on **GUARDIANS'** behalf should **GUARDIANS** be immediately unavailable.

THIS AGREEMENT SHALL BE BINDING ON SAID MINOR, SAID GUARDIANS AND THEIR SUCCESSORS.

WE FULLY UNDERSTAND THE AFOREMENTIONED AND ARE UNDER NO COERCION TO SIGN BELOW.
